You will enjoy your time as the meeting will be held in an attractive tourist place, in low season, in a pleasant but not luxury place.

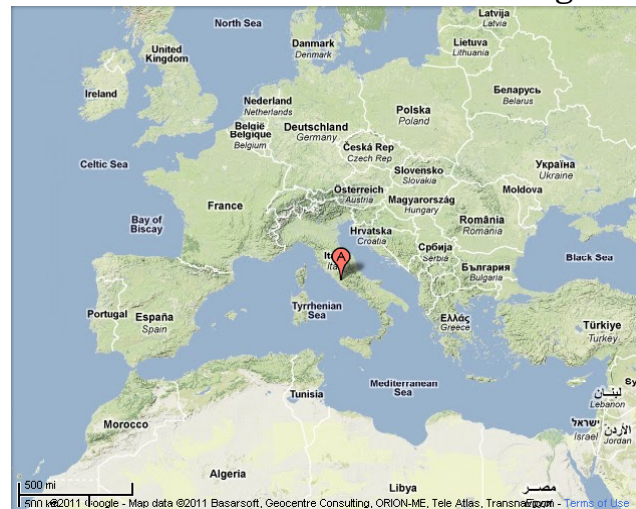
For this edition we selected ROME, the legend deals with one of the ancient Greek colony in Italy, really a link among some villages established near the Tiber about one thousand b.C..

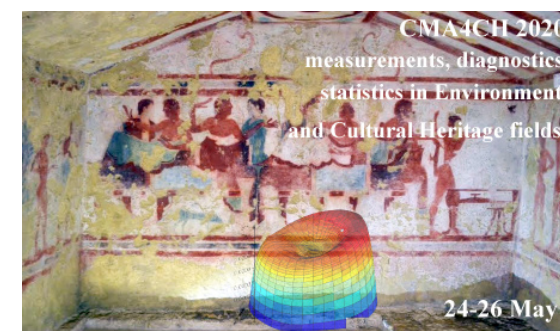
